**Review of Marking of externally assessed components (Service 2)**

A check that our examiners have marked externally assessed components correctly. This includes:

- a review of marking of units/components by a senior examiner

Note: This service isn't available for internally assessed/externally moderated coursework components.

**Review of Marking of externally assessed components (Service 2) + Access to script - post review of marking (ATSPE)**

A check that our examiners have marked externally assessed components correctly. This includes:

- a clerical check (Service 1)
- a review of marking of units/components by a senior examiner

Note: This service isn't available for internally assessed/externally moderated coursework components.

And Candidates will be able to receive the photocopy of the answer script after the post review of marking.

**Access to script - Original (ATSO)**

Candidates will be able to receive the original and photocopy of the answer script.
